## COVID-19 Extension Program

Skip up to two (2) consecutive months of payments on your eligible consumer loan to help alleviate concern about paying your bills. We will waive processing fees and the 6-month loan life requirement, so you can skip payments even if your consumer loan is new.

For the fastest and easiest service, we encourage you to submit your request electronically by logging in to your [Internet Branch](#) or [Mobile Branch](#) account and navigating to the "Skip-A-Pay" form. You may also access the form by [clicking here](#), but please allow up to five business days for manual processing.

**Important:** To skip more than one loan payment, please submit the electronic form TWICE, once for each requested month.

\*This offer does not apply to business loans, credit cards or real estate loans. Loan must be current.

For APCU VISA® Credit Card assistance, please refer to your next statement. Waived payment opportunities may be available for eligible cardholders.
